If the <b>Guardian</b> can no longer retain possession of the <b>Puppy/Dog</b> , the <b>Guardian</b> is notify the <b>Breeder</b> immediately; the <b>Breeder</b> shall resume full ownership and/or place the <b>Puppy/Dog</b> in a suitable home. In the event that the owner passes away and an immediate family member is unable to take possession, the <b>Puppy/Dog</b> must be returned to the <b>Breeder</b> . Any refund will be at the <b>Breeder's</b> discretion.
